Rule on Preparation and Defense of Bachelor's Thesis before the Commission

Article 1 The aim of the bachelor's thesis

- 1. Bachelor's thesis represents a summarizing work, through which students' skills of argumentation, analysis and synthesis, as well as vision of the problem and evaluation possibilities in the specialty are checked.
- 2. The format of Bachelor's thesis involves selecting the topic of research and analysis by a student, as well as choosing a supervisor for the thesis, consulting with him/her, pursuing independent work, collecting, processing and making a critical analysis of the information related to Bachelor's thesis.
- 3. Bachelor's thesis aims at developing students skills for working independently, analyzing and synthesizing information, giving them an opportunity to form, express and defend research methodology, as well as integrate theoretical knowledge and empirical material with research topic.

Article 2

1. A topic for Bachelor's thesis and a supervisor is chosen by a student. The topic for Bachelor's thesis is selected on the basis of compiling the opinions of student and a supervisor from the topics approved by the Faculty Council.

2. The head of the bachelor's thesis may be a person elected to the academic position of the university or a specialist in the invited field, who has a doctorate degree in the relevant field.

Article 3 Language of the Bachelor's Thesis

- 1. The bachelor's thesis is written in Georgian.
- 2. Students enrolled in a foreign-language bachelor's program submit their thesis in the language in which their studies are conducted.

Article 4 Structure of the Bachelor's Thesis

1. The structure of the bachelor's thesis should include the following sections in the given order:

- 1.1. Title page
- 1.2. Declaration page
- 1.3. Abstract (in Georgian and English)
- 1.4. Table of contents
- 1.5. List of abbreviations (if applicable)
- 1.6. Introduction
- 1.7. Main body of the text
- 1.8. Conclusion
- 1.9. Bibliography
- 1.10. Appendices (if applicable)
- 2. Optional Components of the Bachelor's Thesis are:
- 2.1. List of abbreviations, tables, graphs, and other illustrations
- 2.2. Appendices

3. The title page should be completed according to the following rules:

Below the Logo:

- Under the Caucasus International University (CIU) logo, the full name of the higher education institution should be indicated: Caucasus International University (Font size: 14).
- With 2-3 cm space between, the faculty name should be specified (Font size: 14).

- With Another 2-3 cm space between, the student's full name should be written in the nominative case (Font size: 14).
- The title of the bachelor's thesis should be centered (Font size: 16 The word "theme" should not be included, and quotation marks are not required).
- Below the title, the bachelor's program name should be written (Font size: 14).
- Under the program name, the academic degree to be awarded should be specified (Font size: 14).
- On the lower right side, the thesis supervisor's full name, academic degree, and academic position should be indicated.
- At the bottom center, the location and year of thesis completion should be written, (ex: Tbilisi 2023; Font size: 14).
- 4. Annotation provides a summary of the thesis, consisting of approximately 150-250 words. It should be written in both Georgian and English. The English-language annotation must include the student's full name on the right side and the exact title of the thesis centered in the middle section.
- 5. The table of contents should include the titles of all chapters and paragraphs in the bachelor's thesis, listed sequentially with their corresponding page numbers indicated on the right side. Page numbering should begin from the page following the table of contents, taking into account the title page, declaration, annotation and table of contents pages. Page numbers should be placed in the bottom right corner using Arabic numerals.
- 6. The introduction serves as the general section of the thesis (comprising up to 15% of the total work). It should include:
 - Relevance of the topic
 - Research objectives
 - Research tasks
 - Research question(s) and, if necessary, hypothesis
 - Subject and object of the research
 - State of research on the problem (literature review)
 - Methodology and research methods used
 - Significance of the study
 - Material and technical resources used (depending on the field specifics)
- 7. The main text should be divided into chapters and subchapters. Chapters should be numbered sequentially. Subchapters should be numbered with both chapter and subchapter numbers. Chapter title font size: 16. Subchapter title font size: 14. Introduction, each chapter, and conclusion must start on a new page. Subchapters must continue on the same page unless they start a new chapter.
- 8. The conclusion presents the main theoretical and practical results of the bachelor's thesis. (It should comprise up to 10% of the total thesis volume). The conclusion may include key findings and insights derived from the research.
- 9. Requirements for Cited Literature:
 - The bibliography must be presented in alphabetical order (first Georgian-language sources, then foreignlanguage sources, followed by links—abbreviated in the printed version but complete in the electronic version).
 - Any illustrative material used in the text—such as tables, diagrams, images, histograms, and schemes must be numbered. The numbering should correspond to the section of the paper and the order of the material. For example, Table 2.1, Table 2.2, etc.
 - If the bachelor's thesis includes material protected by copyright (e.g., illustrations, spectra, drawings, etc.), the author must obtain permission from the relevant publisher or author. The corresponding copyright permission letter should be included as an appendix in the thesis.
 - Each bachelor's program requires students to use either the Chicago citation style (footnotes) or the APA style when preparing their bachelor's thesis or project.

Specifically:

Chicago Citation Style: Used by students of the Bachelor's programs in International Relations and English Language and Literature.

APA Citation Style: Used by students of the Bachelor's programs in Journalism, Management, Tourism, Finance, Business Administration (both in Georgian and English), and Information Technology (both in Georgian and English).

The bibliography is formatted according to the respective academic style.

10. Formulas used in the text must be numbered only if they are referenced later in the document. The numbering of formulas should use Arabic numerals, for example, (4.5), which indicates the 5th formula of the 4th chapter.

11. Footnotes and additional information in the form of endnotes, if necessary, should be attached at the bottom of each page with continuous numbering.

12. For abbreviations used in the bachelor's thesis that are not commonly known, it is recommended that the author provide a list and explanation of these abbreviations to make the thesis more understandable. The list of abbreviations used should be placed in the introduction section of the thesis, after the table of contents.

Article 5 Text Formatting Rules

- 1. The bachelor's thesis text must be typed on A4-sized paper (297x210 mm) and printed on paper with a density of 80 g/m². The page orientation should be vertical. Printing should be done on one side only. Photographs and other special-purpose tables may be printed on A4 photographic paper. In case of using larger paper sizes (e.g., for schemes), any format may be used, but the corresponding pages should not be bound together with the main text.
- 2. Font type Sylfaen;
- 3. Font size for the text -12;
- 4. Font size: 16 for headings, 14 for subheadings;
- 5. Font size for footnotes 10;
- 6. Line spacing 1.5 interval;
- 7. For smaller sections (such as table of contents, list of tables and figures, summary, footnotes, and others) the line spacing should be 1;
- 8. Margins on the page: Left 30 mm, Right 15 mm, Top 25 mm, Bottom 25 mm;
- 9. The thesis volume, depending on the field's specifics, may range from at least 30 pages to no more than 40 pages (including bibliography).

Article 6 Plagiarism

- 1. Plagiarism in a thesis refers to the use of other authors' ideas, phrases, or sentences without proper citation of the source.
- 2. The term plagiarism (from the Latin plagiatus, meaning "Stolen") refers to the intentional or unintentional act of presenting someone else's ideas as one's own. These "ideas" can be in the form of printed or electronic material, ranging from simple sentences to entire paragraphs. This can also include statistical data, laboratory research results, works of art, etc.
- 3. Within 7 days after the submission of the thesis, the Dean's office, in coordination with the responsible structures, will check the thesis for plagiarism using an anti-plagiarism program.
- 4. In any case of plagiarism detection, disciplinary actions will be taken against the student, as outlined by the university's internal regulations. See the "Plagiarism Detection and Response Procedures."

Article 7 Submission and Defense of the Bachelor's Thesis

- 1. The bachelor's thesis must be submitted to the appropriate faculty, to the program director, by the end of the 15th week of the semester.
- 2. The bachelor's thesis must be bound in a binder on A4-sized paper.
- 3. The student must submit a complete electronic version of the thesis on a CD.
- 4. The thesis must include a conclusion and evaluation from the thesis supervisor.
- 5. The thesis will be accepted for defense if it has received a positive evaluation from the supervisor.
- 6. The program director will assign an examiner (reviewer) for the thesis.
- 7. The reviewer must receive the thesis at least 10 days before the defense. The reviewer must submit a written review 3 days before the defense.
- 8. The thesis will be permitted for defense if the reviewer gives a positive conclusion. If the review is negative, the supervisor is required to prepare a reasoned response to the review. The supervisor may either agree with the reviewer's conclusion and prevent the thesis from going to the defense committee or disagree with the

negative evaluation and, based on the reasoned written response, allow the thesis to be presented to the committee.

- 9. If the thesis is submitted late, the defense will be postponed by one semester.
- 10. A student who misses the defense is allowed to defend the same thesis in the following semester.
- 11. If the thesis is evaluated between 41 and 50 points, the defense will occur in the next semester. A thesis can be presented for defense only twice in different semesters.
- 12. If the thesis is evaluated 40 points or less, the student is not allowed to continue working on the same topic in the following semester.
- 13. The thesis is evaluated by the reviewer and the supervisor according to the criteria specified in Article 8 of this regulation, and by the committee according to the criteria in Article 9.

Article 8 Evaluation Criteria:

- 1. The bachelor's thesis is evaluated on a 100-point scale. The evaluation is carried out by the thesis supervisor (30 points), the thesis reviewer (30 points), and the defense committee during the public defense (40 points).
- 2. The thesis supervisor will provide an interim evaluation of the bachelor's thesis in the 8th academic week, within a range of 10 points, based on the following criteria:

- 3. The thesis supervisor provides their final conclusion along with the evaluation before submitting the thesis to the reviewer. In their final conclusion, the supervisor describes the work completed by the student throughout the semester, evaluates the research part of the thesis, the quality of its formatting, and provides an overall evaluation within a range of 20 points.
- 4. The supervisor evaluates the bachelor's thesis at the end of the semester based on the following criteria:

5. The thesis reviewer submits the review with the evaluation 3 days before the defense.

- 6. The review includes a general evaluation of the thesis, the relevance of the topic, the analysis of the material developed, and the language and style of the thesis. The reviewer provides their comments and recommendations on the bachelor's thesis topic.
- 7. The reviewer evaluates the bachelor's thesis within a range of 30 points based on the following criteria:

8. Depending on the specifics of the bachelor's program, based on the program director's justified recommendation, the rector's order may approve alternative evaluation criteria for the bachelor's thesis. However, these criteria must not significantly differ from the evaluation principles outlined in this article.

Article 9 Committee

- 1. The composition of the bachelor's thesis defense committee is approved by the rector through an order, based on the faculty's proposal.
- 2. The committee consists of at least 3 members and a secretary for the meeting.
- 3. The committee has a chairperson, who is a specialist in the field and is not part of the university's academic staff at the time of the defense.
- 4. In order to be admitted to the defense, the student must have achieved the minimum competency threshold in the evaluations from the thesis supervisor and reviewer at least 16 points in each evaluation component.
- 5. After the evaluations by the supervisor and the reviewer, the bachelor's thesis is evaluated by the defense committee in a closed session immediately after the defense. The committee evaluates the thesis within a range of 40 points, and the final score is the average of all members' evaluations. A positive evaluation requires a committee score of at least 21 points.

Article 10. Bachelor's Project

1. Depending on the specifics of the program, a bachelor's project may be considered as a component instead of the bachelor's thesis.

- 2. A bachelor's project is a small-scale research component, which may carry no more than 6 credits in the program.
- 3. All the conditions that apply to the bachelor's thesis under these regulations also apply to the bachelor's project, except for the different regulations specified in this article.
- 4. The volume of the bachelor's project, depending on the specifics of the field, may range from no less than 20 pages to no more than 30 pages (including the bibliography).
- 5. The bachelor's project does not require a review and is evaluated on a 100-point scale. The evaluation is carried out by the project supervisor (60 points) and the defense committee during the public defense (40 points).
- 6. The supervisor of the bachelor's project will provide an interim evaluation in the 8th academic week within a range of 20 points based on the following criteria:

- 7. The supervisor of the bachelor's project provides their final conclusion along with the evaluation at the end of the semester. In their conclusion, the supervisor describes the work completed by the student throughout the semester, evaluates the research part of the project, and the quality of its formatting. The supervisor evaluates the bachelor's project at the end of the semester within a range of 40 points, for a total of 60 points.
- 8. The supervisor evaluates the bachelor's project at the end of the semester based on the following criteria:

- 9. To be admitted to the defense of the bachelor's project, it is required that the project supervisor's evaluation be at least 31 points.
- 10. After the evaluation by the bachelor's project supervisor, the bachelor's project is assessed by the total score of the defense committee, immediately after the completion of the defense in a closed session. The final evaluation is the average of all committee members' assessments. A positive evaluation requires the committee's score to be at least 21 points.

Article 11. Concluding Provisions

- 1. The procedure for the completion of the bachelor's thesis/bachelor's project and its defense before the committee is approved by the university's chancellor through an order.
- 2. Amendments and additions to this procedure are made by the chancellor's order.
- 3. With the approval of this document, the chancellor's decree #01-36 dated March 27, 2014, which approved the " Rule on Preparation and Defense of bachelor's Thesis before the Commission," is hereby declared invalid.
